2. What are the Collection Methods of Your Personal Data?

Your personal data specified above in categories are collected through printed and electronic forms, contracts, CV, e-mails, invoices, information systems, electronic devices, business cards, our social media accounts, references and documents declared by the concerned person.

3. What is the Legal Reason for Collecting Your Personal Data?

Your personal data processed by Leo Drive in line with the realization of the purposes described above, under express consent given in accordance with the relevant legislation, especially the Turkish Commercial Code, Turkish Code of Obligations and LPPD regulations, expressly stipulated in the laws, the performance or establishment of the contract, the legal obligation of the data controller, the establishment, exercise or protection of the right and the legitimate interest of the data controller.

4. Do We Transfer Your Personal Data to any Third Party?

Your personal data, within the scope of the legal regulation may be transferred to:

- To cloud service providers abroad for the purposes of conducting business activities, ensuring in-house document management and storage, conducting interviews with candidates through third-party information systems, ensuring information security, and conducting audit and ethical activities;
- To the Competent Public Institutions and Organizations for the purpose of carrying out the activities in accordance with the legislation, following and executing the legal affairs, informing the authorized persons, institutions and organizations,



- To our Accountants, Suppliers and Third Parties for the purposes of executing service procurement processes, executing contract processes, following and executing legal affairs, executing financial and accounting works, executing information security processes, and conducting business activities,

5. What Are Your Rights Regarding Your Personal Data?

Concerning your personal data you have the right to:

- Learn whether your personal data are processed,
- If your personal data has been processed, requesting information about it,
- • Learn the purpose of processing personal data and whether they are used in accordance with its purpose,
- Know the third parties to whom your personal data is transferred in the country or abroad,
- Require correction of your personal data if it is incomplete or incorrectly processed,
- Require the deletion or destruction of your personal data within the framework of the conditions stipulated in the LPPD legislation,
- When you request the deletion or destruction of your personal data and correction of incomplete or inaccurate data, require this situation to be notified to the third parties to whom we have transferred your personal data,
- If you suffer any damage due to unlawful processing of personal data, claim the compensation of this damage.

5. How Can You Exercise Your Rights?

You can communicate your applications and claims through Relevant Person Application Form available at https://leodrive.ai/uploads/application_form.pdf;

- By personally applying to Leo Drive with a valid ID,
- • By sending an e-mail to kvkk@leodrive.ai of Leo Drive with a petition signed with a mobile signature or a secure electronic signature,
- • By sending a petition signed from your KEP address to Leo Drive to the address of leo@hs01.kep.tr,
- • By sending it to leo@leodrive.ai from the e-mail address previously reported to Leo Drive and registered in our system.



In accordance with the Communiqué on Application Procedures and Principles to the Data Controller, it is mandatory to state the name, surname, signature if the application is written, the T.C. identification number, (passport number if the applicant is a foreigner), residence or workplace address for notification, e-mail address, telephone number and fax number, if any, and information on the subject of the claim.

The Relevant Person must clearly and comprehensibly state the subject claimed in the application, which includes explanations regarding the right to be exercised and requested to use the above-mentioned rights. Information and documents relating to the claim must be attached to the application.

Although the subject of the claim must be related to the person of the applicant, if acting on behalf of someone else, the applicant must be specifically authorized in this regard and this authority must be documented (special power of attorney). In addition, the application must contain identity and address information, and documents confirming identity must be attached to the application. Claims made by unauthorized third parties on behalf of someone else will not be considered.

6. How Long Will Your Requests Regarding the Processing of Your Personal Data Be Answered?

Your claims regarding your personal data are evaluated and answered within 30 days at the latest from the date they reach us. In case your application is evaluated negatively, the reasons for rejection are sent to the address you specified in the application, by e-mail or postal mail, in one of the methods selected in the Relevant Person Application Form, which you can also access from our website.
